Refer to Article V.C.1. & 2 of the Bylaws. This form is for proxies limited to a single meeting. If you wish to assign a proxy for a longer period, please contact our Congregational Administrator at admin@muuf.org. Only a Member of the Fellowship in Good Standing (as defined in the Bylaws) as of 30 days prior to a Congregational Meeting (a "Voting Member") may vote in the meeting. Any Voting Member may cast their vote in this form or by assigning the proxy to another Voting Member in accordance with the Bylaws and these Rules.

If you wish to vote by proxy, you must follow these rules:

1. You must use this official form. The form must be dated and signed in a verifiable manner to be valid and submitted to the Secretary (secretary@muuf.org) or the Congregational Administrator at admin@muuf.org prior to the start of the meeting at which the proxy is to be used.
2. A proxy form may be a copy, but must have an original signature in ink; applied by some verifiable electronic means such as DocuSign; or otherwise verifiable as having been authorized by you.
3. The proxy may be exercised only at the meeting for which it is authorized and only by the person named in the Proxy below **OR** by the Board if the proxy specifically includes a vote (For, Against, Abstain) for each resolution. Please choose by either designating a person as Proxy **AND/OR** voting in the table.
4. No Voting Member may hold a proxy for more than one other Voting Member at a time.
5. Duration. This standard proxy form is limited to voting at a single meeting. You have the right to assign your proxy for a longer period, up to one year. All proxies are revocable on notice at any time.
